### WA State Capitol Flag Raising

On June 17, 2021 I had the honor of being asked to give the Land Acknowledgement at the Annual Pride Flag raising at our State Capitol, as part of my work as a commissioner on the WA State LGBTQ Commission. I appreciated the chance to be able to speak on behalf of all of our ancestors and people of this land, and give voice to important issues facing our Tribal Nations. Below, please find a transcript of the Land Acknowledgement that I shared at the event:

Good afternoon, my name is Josette Ross and I am a descendant of the Iroquois, Salteaux Anishinaabe and Nisqually Absch people and I am honored to stand before you today to deliver this land acknowledgement.

Since time immemorial, these lands that we are standing on today have been the traditional home of the Squaxin Island, Puyallup and Nisqually Tribal people, as well as a center for trade and commerce among many of the Salish Sea tribal nations. Our people have been here for thousands upon thousands of years, thriving, cohabitating, loving, and practicing our traditional cultural ways.

On this day of celebration and raising of this Pride flag here on the steps of the WA State capital, I want to take time to honor and give space to all of our Two-Spirit and LGBTQIA+ Native relatives who have traditionally inhabited a place of honor amongst our tribal communities.

When settler colonial boarding schools and forced religion attempted to wipe our people off this Earth, our Two-Spirit and LGBTQIA+ relatives had to hide who they were in order to survive. Those attempts at genocide were unsuccessful and today we can stand proudly as examples of resiliency, strength and how to move through this world with grace and dignity.

Historical trauma has long been a reality for our people, but we are working hard to forge a path forward. We invite everyone listening today to make a commitment to support Tribal Sovereignty and Native rights by fostering meaningful relationships and truthful conversations and centering Native voices in all our work. This is a small step toward mending past wrongs and supporting a vibrant and strong Tribal future.

Today, and throughout this Pride month, we honor and pay respect to all our Two-Spirit and LGBTQIA+ relatives, out or not, and to all the Native peoples of this land.

### Nisqually Tribal Council Hires a General Manager/Chief of Operations - Pete Ansara

The Nisqually tribal council is pleased to announce the hiring of Pete Ansara as our General Manager/Chief of Operations. His first day was July 26.

In coordination with our contractor, Debra Lekanoff, we rigorously crafted a position description to go with our stated goals of "Enhancing and Strengthening Nisqually Tribal Governance and Homelands for the 21<sup>st</sup> Century."

We believe Ansara, whose background of 25 years in the United States Air Force and years of post-military work for housing authorities in New Jersey and Pierce County, will aid him in helping us provide services to tribal members in a more efficient and organized manner.

Ansara also headed the Korean Women's Association, a registered 501 (c)(3) non-profit organization with 1,500 employees, providing multi-cultural, multi-lingual human services, regardless of race or ethnic background, to diverse communities through education, socialization, advocacy, and support.

A native of Lowell, Mass., Ansara also is a graduate of the University of Oklahoma with a degree in Human Relations and an undergraduate degree in business from Columbia College.

"I am excited about this opportunity to learn and grow with the Nisqually Tribe," Ansara said.

"Our tribe is growing in many directions at a rapid pace," said Willie Frank III, tribal council chairman. "This council wants our capacity as a government to keep up with the pace of the ambitions of our people."

"We want employees to be empowered to be trained and employed in a way that best suits their strengths, to be proud of their job as part of helping the tribe move forward," Frank said.

Lekanoff, the governance contractor, is a Tlinglit tribal member and has worked in tribal governance for decades, including her election as the first tribal woman to the Washington state legislature.

"We will be doing a lot of listening to employees and directors as we move forward," Lekanoff said. Richard Trudell, Santee Dakota Sioux, also consulting with Nisqually, was in the first group of Native Americans to graduate from law school. He helped create the American Indian Law Association and later President Jimmy Carter nominated Trudell to serve on the national board of directors of the Legal Services Corporation (LSC), a federal entity established in 1974 by Congress to provide funding for legal aid programs across the country.

"The outcome for the consultants, as ambassadors of Nisqually council, will be to support the vision to enhance and strengthen tribal governance for the 21<sup>st</sup> century," Lekanoff said.

As part of the consultant process, departmental structures and groupings will be considered as well as ways to make it more efficient and cooperative.

"These are good growing pains," Frank said. "Our strong leaders of the past also knew when it was time to adapt and grow."

### **Nisqually Shellfish Farm Manager**

This summer at the Nisqually Tribe Shellfish Farm, staff is working hard to re-organize the oyster and manila clam beds. Aquaculture practices and methods have been evaluated this past spring to produce a new cost-effective plan for the farm. This new plan will include a dedicated tideland area for oysters and clams

specifically grown for the Nisqually community. Distribution of the shellfish will be seasonal starting this fall and will be a sustainable addition to Nisqually food sovereignty.

The upland area of the farm is also being cleaned up and space being created for small gatherings and teachings in the future. This is an ongoing process with a focus on safety and cleanliness of our beach to accommodate visitors of all ages. In May, Pacific NorthWest DirtWorx provided a much-needed demolition and debris removal of unsafe outbuildings taking up a significant amount of space along the beach. Elder and youth oyster seed grow bags are being planned for spring 2022.

In addition to more community involvement, the

shellfish farm will be continuing limited sales of commercial quality oysters to local markets. Staff will be carefully selecting its buyers to create long-lasting local partnerships that understand the goals and capabilities of the farm. ### **Online Security War**

Tips from the IT-WebDev Department

Cyber-attacks are on the rise, the targets of those attacks are expanding. Attackers are more motivated, and their tactics are becoming increasingly malicious. Apple earlier this year released important and urgent operating system security updates for



iPhones, iPads and iPods; it was found that remote hackers could access these devices.

64% of companies worldwide have experienced at least one form of a cyber-attack. Globally, 30,000 websites are hacked daily and every 39 seconds, there is a new attack somewhere on the Web. The battle to protect privacy will be ongoing, useful tactics include keeping software up to date, using anti-virus and firewall protection, using strong passwords and changing passwords on a frequent basis, installing apps or software from trusted sources and remaining cautious of suspicious emails, phone calls and flyers requesting personal information.

When visiting websites that request any personal information, e.g. filling out an online form asking for account login information, email address, mailing address, phone number, etc., look for the below features; Secure Connection (https) – Look for the lock symbol ( Secure) in the website

address bar.

• **Captcha-** An acronym that stands for "Completely Automated Public Turing test to tell Computers and Humans Apart." It is a type of online challenge–response test, typically matching images or validating a combination text and numerical string and is used to determine whether or not the user is human. An example of a captcha may be seen on the Nisqually Tribe's website at; <u>ttp://www.nisqually-</u>

 Two-Factor Authentication (2FA) – A method that adds an additional layer of security beyond just a username and password to online accounts. It requires an additional login credential such as entering a six-digit number that is typically sent via text to a registered phone number or via email.



### **New Pharmacy Pickup Instructions**

### **PROCESSING A NEW PRESCRIPTION OR REFILL**

Most prescriptions are sent to the pharmacy electronically from your

provider. This process could take up to 10 minutes for the pharmacy to receive the orders. Once the pharmacy gets to your prescription, it is placed in the order which it was received. The prescription label (s) are typed, the drug is pulled and the prescription pills will be counted. The pharmacist will verify that all of the information including pt. name, Dr. name, drug, dosing, and quantities are all correct. The Pharmacist will also check for drug interactions and any duplications of



therapy among other important things. Once this final check is done the automatic system will let you know that your RX is ready for pickup.

# FILLING YOUR PRESCRIPTION AT OUR NEW PHARMACY

To ensure we maintain accurate contact information on the pharmacy

system, we will ask you to update or verify your information such as: phone number, address, and insurance info. This way we can properly notify you by text or phone call that your prescription is ready for pick up.

Note: Depending on how many prescriptions you have and when we receive your request, this process can take anywhere from 15-30 minutes.




### Nisqually Elders Lead the Way

Vaccines aren't perfect, but they do lower the risk of spreading COVID and decrease the risk of death from COVID.

### Four Ways to Boost Your Immune System

Having a healthy immune system is the best way to fight all types of infection. Now during the COVID-19 pandemic it is especially important to keep your immune system in tip-top shape and ready to fight the virus that causes COVID-19 illness. **Here are some things you can do to boost your infection fighting powers:** 

1. Get vaccinated. Once you have received 2 doses of the COVID vaccine you will have infection



fighting antibodies and white cells that can recognize the virus. This gives your immune system a head start and you will be less likely to get severely ill if you catch the virus.

2.**Sleep**. Rest well every night. Getting 7-9 hours of sleep each night is important for your health. Turn off the TV and phones and let your body gather strength for the coming day.

3.**Take care of diabetes** and other chronic illnesses. When your blood sugar runs over 140 it makes it harder for your white cells to fight infection. Well controlled chronic health issues mean you are in better

shape to face an acute illness.

4. **Take Elderberry syrup** to boost your immune system. This along with a healthy diet full of fruits and vegetables will keep you strong through all the seasons.




### Variants and Vaccinations

You may have heard of the Delta variant of COVID-19. Originating in India, it has recently become the dominant strain of COVID-19 in the United States. Studies show that the Delta variant is 60% more contagious than previous strains, and doubles your risk of hospitalization due to the illness. The good news, is that the 2 dose COVID 19 vaccines remain effective in combating this more dangerous strain. Health Department staff has been reaching out to those who have not completed their 2 dose series, as we now know that a single dose does not provide adequate protection against the Delta variant. In the following chart, you can see how quickly the delta variant (in dark orange; B.1.617.2) has risen to become the dominant COVID strain in the US. As the number of cases, and deaths, from COVID drops, and restrictions on social gatherings lessen, one group is still seeing high rates of COVID-19 cases and deaths: the unvaccinated

According to research from the CDC, unvaccinated people account for 98% to 99% of all COVID-19 deaths in the United States, since the start of 2021. This means that the disease that just a few months ago threatened the entire nation is now almost exclusively circulating amongst a shrinking few. With the delta variant in mind, Health Staff have also been doing significant outreach to reach those who remain unvaccinated, to ensure that they have the protection of the vaccines.

#### Nisqually Tribe Health Department: Hired March of 2021


My name is Chris Scaniffe, and I am happy to be serving as a Registered Nurse with the Nisqually Tribe. I

## BRIGHTON CREEK

Brighton Creek staff has been working diligently with our focus on construction needs to bring Brighton Creek up to specific codes in Pierce County.

#### **Construction and Covid -19 Quarantine Site:**

We continue to prepare for Covid -19-Delta Variance to be ready as needed. We are very excited we were able to secure COVID funding to complete the ADA bathrooms and Dining Hall remodel.

We are busy with construction, licensing paperwork and meeting code requirements. The construction process has been taxing with all the requirements making the process quite time consuming and lengthy. We have continuously had to jump through several hoops, such as the cost in lumber, the wait times for obtaining permits through Pierce County, etc. and with the help of the Building Department, we hope to overcome these challenges and accomplish the following this year:

- We will be upgrading and remodeling the Dining Room, ADA Bathroom and Women & Men's bathrooms.
- Installing Septic system for RV Park
- Repainting the interior and exterior of the 13 cabins and lodge
- Installing fencing around perimeter of facility
- Constructing a carport for equipment

As of right now, we are in the process of painting the interior of the cabins, assembling and installing furniture, and decorating the interior to create a comfortable transitional environment and to make every person feel at home. We are also working with the Building Department to repaint the exterior of the cabins, the lodge, and the dining hall at Brighton Creek to bring a refreshing look to the facility. Our hope is to continue to move forward in bringing the



community and tribal members a very well maintained healing & retreat center. We are excited to see the potential and transformation in the facility, and have hopes of opening up by 2022.


