The Nisqually Indian Tribe promulgates the following regulation. This fishery shall be conducted in accordance with the provisions of the Federal District Court Order CV 9213, Sub-proceeding No. 89-3.

SPECIES:	Geoduck clam, Panopea abrupta
On/Off Reservation:	Off
LEGAL GEAR:	High pressure, handheld water jet, continuous 5/8" inside diameter
DAYS/HOURS:	<b>Puget/Mill Bight –aka Millget (#14000)</b> will be open Saturday, Monday, Tuesday & Wednesdays. from 7am to 3pm
	<b>Fox Island North (#11200)</b> <i>will be open Sundays.</i> from 7am to 3pm
ESTIMATED EFFORT: ESTIMATED HARVEST	<ul><li>8 Vessels</li><li>Approximately 6,000 pounds per day</li></ul>
QUOTAS:	Eligible <i>returning</i> divers may take up to <b>2,160</b> pounds of their original IDQ in Subregion C (the Nisqually area) <i>and</i> <b>675</b> pounds in Subregion B (the In-common area).
	<u>New and Recertified divers may take up to <b>1,000</b> pounds in Subregion C (the Nisqually area.).</u>
<b>Reporting:</b>	All geoduck clam sales must be recorded on Treaty Indian Fish Receiving Tickets. The following information should be included: 2012 Geoduck Atlas tract number, commercial pounds, harvester name, buyer name and harvester signature.
	Subsistence pounds must be recorded separately on the monitor weigh out slips.
OTHER PROVISIONS	Harvest activities must comply with the Tribal 2025/26 Annual Shellfish Regulations.

Only Nisqually Tribal members or NDNR staff are allowed on Nisqually vessels unless otherwise approved in writing by the Nisqually Fish Commission.

Commingling Geoduck clams from tracts is strictly prohibited. Geoduck must be weighed out and tagged prior to leaving the Tract.

## <u>All boat captains shall radio/call the geoduck monitor as each diver</u> <u>enters/exits the water.</u>

Individuals are solely responsible for tracking the pounds remaining in their IDQ.

Disposing of geoduck shell in marine waters is prohibited.

## JUSTIFICATION: Harvest available Geoduck clam resource. Closing of Nisqually tract, opening of Millget geoduck tract. -Clarification of tract name.
