The intent of the Children's Activities Program is to aid Tribal member students with monetary assistance for 1) participation in a organized youth sports team and purchasing sports equipment (with letter from school); 2) entry into a youth sports tournament: 3) early development activities (swimming, dance, pre-school), Native American arts and crafts instruction and supplies. For Native American Arts and Crafts and Supplies

Must have an announcement from vendor indicating: name of vendor and address, the name type of arts and crafts class, timeframes of classes, cost per activity, i.e. basket weaving, carving etc. billing/invoice information. Vendor must have a documented history of performing Native American cultural arts and craft instruction; Applicant can use funding to purchase arts and crafts supplies, only if it's a requirement of the courses, Applicant cannot use funds to put on a workshop. Applicant must be participating in workshop, not teaching it. This activity does not pay for travel.
